## A) The 'Help fund the production of Up Styx Creek' Motion

Proposer: Karina Oakley

Seconder: Ella

This JCR notes:

- A production of 'Up Styx Creek', an original comedy musical by Jemima Freeman (Merton) and Charlotte Walker (LMH), with new songs by Jack McMinn (St Cross), Peregrine Neger (Jesus) and Wing Hei Woo (Anne's), will be taking place in week 5 in the Keble O'Reilly theatre.
- The cast and crew currently consists of 33 people from across 15+ colleges and numerous degrees, so it is a large scale production and involves lots of people!
- The projected costs are projected to be around £2000. About £700 is needed just to pay for the venue and the rest is for costumes, set/props, lighting, and marketing.
- A St John's student (Karina Oakley) is heavily involved in the play, performing as four characters throughout, as well as helping with marketing.

This JCR believes:

- The JCR should help fund this production to support student drama and creativity and add to the vibrant college and university theatre environment.
- Since it is a piece of new writing, it is especially vital to support this production as it encourages new talent.
- The high costs of renting the Keble O'Reilly and other props/ staging mean this project will struggle for funds without JCR support.

This JCR resolves to:

 Give £100 to help fund the production costs of 'Up Styx Creek' from the Financial Motions Budget-Kendrew Arts Fund

# C) The "Support Blood Wedding" Financial Motion

# This JCR notes that:

- 0. Federico García Lorca's *Blood Wedding* (in a new translation by Emma Nihill Alcorta) is being staged at the Oxford Playhouse in Week 6 of Trinity 2025.
- 1. Written in the summer of 1932, Lorca's acclaimed rural tragedy is a story of arid land and tough people, where societal expectations are rigidly defined and hidden yearnings simmer under the surface of convention. *Blood Wedding* urgently interrogates what happens when individual yearning batters against the walls of tradition.
- The £300 grant from St John's College is vitally important for the success of the production. This grant would significantly contribute to the production, due to the scale of the project, with over 50 Oxford students involved in the cast and crew

# This JCR believes that:

- b. Supporting *Blood Wedding* benefits the student theatre and arts scene in Oxford as a whole it is important to support student participation in drama after an extended period of restricted artistic and theatrical projects during the pandemic. Supporting *Blood Wedding* and the newly established *Full Moon Theatre* in this way would be an excellent opportunity for the SJC JCR to encourage the extra-curricular involvement of Oxford JCR and MCR members and help provide entertainment for members of the university and beyond.

# D) The 'Support Frequent Fliers Productions' Financial Motion

# This JCR notes that:

- This student production company was started by a John's student and wishes to put on their new play.
- Beyond the founder, two other John's students are on the crew for the production.
- The play is called 'An Anthology of Pairs' and is about the tumultous relationship between a Jewish mother and daughter who have differing views on faith.
- Frequent Fliers has already successfully bid for a BT slot in week two of Trinity Term, Tuesday Saturday at 7:30.
- We will provide a written report about the event that would go on the news section of the JCR website.

# This JCR believes that:

- This project should be given funding because it is an entirely student-led creative effort.
- There are John's students involved, all of whom are Freshers and this will be a first move into putting on theatre at Oxford. The play itself tackles challenging but moving topics that will be familiar to many students regardless of their background and will speak to a larger community in Oxford as well.
- Additionally, due to Frequent Fliers being an all new production company, it has no money currently to fund its project, while there are other funding bodies (such as CMDF) which we have also gone to for funding, we will not be able to afford our venue without the support of JCR funding.
- This is particularly because set, prop, marketing and lighting expenses are already being funded by other grants and loans. The amount we are asking for (£230) is the exact cost of renting out the BT space for the week we will need it, and the show cannot happen without it.

Give £230 to Frequent Fliers productions from the Kendrew Arts Fund to allow them to put on their upcoming production 'An Anthology of Pairs'

# E) The "Fund Jack the musical!" Financial Motion

# This JCR notes that:

- Jack the musical is a new student written musical about Jack the ripper bidding pitch trinity w2/3.
- It features 2 Johns students in a small cast of 8. An exciting project that strives to give a new answer to the case!

# This JCR believes that:

- We should fund Jack because the show contains 2 Johns members, one playing the lead.
- It's an exciting new show and supporting new student writing is incredibly important.
- We have a two-week slot confirmed for Edinburgh fringe and have already been rehearsing for multiple weeks.
- The project being a musical entails additional costs, as opposed to a play where it is easier to keep costs down.
- The show itself tackles taboos and is quite representative, where oxford theatre can often lack. Without giving too much away, the plot is an exciting take on the mystery of the ripper that attempts to view the age-old question through new historical lenses.
- The Proposer will be required to write a written report to be uploaded to the News section on the JCR website

# F) The "Provide 2nd Year Classicists with Powdered Substances" Financial Motion (Removed via friendly amendment)

#### This JCR notes that:

- a) Classics students at St John's are currently taking 'Mods' exams. These exams historically take place in Hilary term as opposed to Trinity term.
- b) Members of the JCR typically celebrate the completion of exams (e.g. 'Prelims' and 'Finals') with eco-friendly coloured powder.
- c) The E&E (Environmental and Ethics) Officer typically purchases these materials for Trinity term, however 'the company that we use...doesn't start delivering until the middle of Trinity' (Swan 2025, personal communication).
- d) The E&E budget 'has been cut this year...[and] all the budget is required for the order for Trinity term' (Swan 2025, personal communication).
- e) Without the *ad hoc* purchase of eco-friendly coloured powder, Classics students at St John's will be unable to celebrate their 'Mods' in the standard fashion.

#### This JCR believes that:

f) The Classics students and those involved in these celebrations would therefore benefit from the purchase of eco-friendly coloured powder.

g) Give £13.95 from the Financial Motions Budget in order to purchase eco-friendly coloured powder.
